Your kind attention is drawn to the Annual Contribution of your college towards the various funds for the year 2013-2014.

**CULTURAL ACTIVITIES:** A sum of Rs. 6/- to be collected per student annually towards the Cultural Activities Fund which is utilized for the University Youth Festival and participation at the AIU sponsored Inter University West Zone Cultural Competitions.

**SPORTS & CULTURAL ACTIVITIES (ASHWAMEDH & INDRADHANUSHYA)**

As per Circular No. CONCOL/479/of 2008, dated 4<sup>th</sup> November, 2008, with reference to amendments to Ordinances Nos.3853,3854,3855 and 3856 you are requested to collect a sum of Rs.30/- per students per annum out of which your goodoffice will contribute Rs.24/- only per student to the University.

**DISASTER RELIEF FUND (AVHAN):** As per the resolution adopted by the Management Council vide Item No. 11 at its meeting held on 29<sup>th</sup> September 2001 a sum of Rs.10/- be charged per student at the time of admission to students studying at all the courses for the academic year 2013-2014.

You are also requested to note that with reference to the above in case your college has not contributed towards these funds during the earlier years you are once-again requested to send the contributions alongwith the **students' strength of your college, academic year and separate Cheque/DD are to be sent for each Contribution**, as the Department is answerable to competent authorities of the Government.

You are also requested **not to send any contributions** directly to the office of Registrar/ Finance and Accounts Officer, University of Mumbai.

Kindly remit the above contributions **on or before 30<sup>th</sup> September, 2013** through **Cheque/DD which may be drawn in favour of the "Finance and Accounts Officer, University of Mumbai"** and should be forwarded through the office of the **Director, Students' Welfare, University of Mumbai**, Vidyapeeth Vidyarthi Bhavan, 1<sup>st</sup> Floor, B-Road, Churchgate, Mumbai - 400 020 .
