RULES AND REGULATIONS

Subjects : 1. Role of YOUTH in eradication of DOWRY Custom. 2. *Ex-parte* Love Affair : Social Problem ? 3. Social Reformers in Maharashtra.

Day, Date & Time : Saturday, 12th January 2013 at 10.00 a.m. (YOUTH DAY)

Venue : Vidyapeeth Vidyarthi Bhavan, 4th floor Auditorium, Churchgate, Mumbai 400 020.

Eligibility : All Recognized Universities from Maharashtra State can participate in the Competition. Every University will nominate Two Student Representatives (preferably one Boy & one Girl Student) from affiliated Senior College or University Departments. The Names should be sent in the prescribed format along with Entry Form duly certified by the Registrar or Authorized Officer of the University to the effect that the participants are the bona fide students and are authorized to represent the University. The participants are advised to produce their valid IDENTITY CARDS at the venue.

Language Option & Duration of the Speech: The participant may speak either in Marathi, Hindi or English. Duration of the speech will be TEN Minutes. Participants are not allowed to read out their speech from the papers however they can refer to the points written on a small piece of paper.

Submission of Entry Forms : University will submit two names of the representatives to our above address along with nominal Entry Fee of Rs.500/- by M.O. or Demand Draft in the name of Anti Dowry Movement, Bombay payable at Mumbai, on or before 11.1.2013.

Traveling Allowance : Only participants authorized to represent the University will be reimbursed FIXED TRAVELING ALLOWANCE from the University/College to Mumbai & return, equal to IInd Class Railway fare only on production of the Tickets. Participants from Greater Mumbai will be reimbursed Rs.50/- towards local conveyance.

Board & Lodging Arrangements : Participants will have to arrange for their own lodging. They will be provided with Breakfast at 9.30 a.m., Lunch at 1.30 p.m., and Tea at 4.00 p.m. at the venue of the competition on Thursday, the 12th January 2013.

PRIZE Scheme : The winning University will be awarded RAJENDRA SHIELD. The College/University Dept. first in order of merit will be awarded Trophy. The Student first in order of merit will be awarded Replica of the Trophy, Cash Prize of Rs.1000/- with Merit Certificate and a Book on Mahatma Gandhi's Life. There will be additional two consolation Cash Prizes of Rs.500/- & Rs.250/- to the students 2nd & 3rd in order of merit respectively with Merit Certificates. Certificates of Merit will also be given to 4th & 5th in order of Merit. All participants will be given Participation Certificates.

Basis of Evaluation : Evaluation will be on Individual Basis and not on Team Basis. The points of evaluation : (1) Grasp of the Subject (2) Presentation of the Subject (3) Eloquence (4) Summarization (5) Effect on Audience.

Result & General : The result will be declared immediately after the competition is over and the prizes will be awarded in the evening at the venue.
