The Directors/ Heads of the University Department, Institutes / Centers, The Principals of the affiliated Colleges conducting the Under Graduate / Post Graduate degree courses in the faculty of Arts, Science and Commerce are hereby informed that in pursuance of the officials communication dated 04<sup>th</sup> May, 2012 from Shri Sanjay Kumar, Principal Secretary Department of Higher and Technical Education Department, Mantralaya, Mumbai – 400032, instructing the University as follows:

  - iii) वरील दोन्हीही पर्यायांचा वापर केल्यानंतरही मनुष्यबळ कमी पडल्यास सेवानिवृत्त झालेल्या अध्यापकांकडुन उत्तरपत्रिकांच्या मुल्यांकनाचे काम करुन घेण्यात यावे.
- २) एमफुक्टो या संघटनेने केलेल्या मागण्यांच्या अनुषंगाने सदर संत्रटनेसोबत चर्चा आहे<sub>.</sub> त्यामुळे वरील पर्यायी व्यवस्थेचा वापर एमफुक्टो संघटनेकडुन बहिष्कार मागे घेईपर्यंतच करण्यात यावा<sub>.</sub> त्यानंतर नियमित अध्यापकांकडुन उत्तरपत्रिकांच्या मुल्यांकनाचे काम करुन घेण्यात यावे.
- 3) तसेच एमफुक्टो संघटनेने सुरु केलेल्या आंदोलनामध्ये ज्या अध्यापकांचा सहभाग आहे अशा अध्यापकांचे महाविद्यालयनिहाय (प्राचार्या, कडुन प्रमाणित करुन) माहिती शासनास कृपया तात्काळ सादर करावी.

They are therefore requested to take note of the above instructions which are received from the Principal Secretary Department of Higher and Technical Education Department, Mantralaya, Mumbai – 400032, and extend all possible cooperation to the University Examination Department by deputing the teachers appointed on temporary or on contract basis. However, the information may also be sent to us on the teachers who have retired from the services of the Colleges / Departments / Centers with their Names, Addresses and Phone Numbers so as to utilize their services for the assessment / moderation of answer books. They are further informed that the information be sent to the Controller of the Examinations in respect of the teachers who have participated in the said boycott and not involved in the assessment work of the University Examinations held in First Half of the year 2012, immediately in the enclosed chart from the colleges so as to enable the undersigned to forward the same to the Department of Higher and Technical Education Department, Mantralaya, Mumbai – 400032 for taking necessary action.

They are therefore requested to bring the contents of the circular to the notice of the teachers by circulating the same and also display it on the notice board of staff common room.
