(Res.) dated 25th January 1999, issued by Shri J.Kumar, under secretary to the Government of India, Ministry of personnel P.G. & Pensions, Deptt. of Personnel & Training, New Delhi, to the notice of all concerned for strict compliance.

"In case the false SC/ST certificate holder takes the shelter of Court, the Hon'ble Court may be approached to vacate the stay order, if granted and to finalise the case on top priority to ensure that the person does not continue to avail the benefits meant for SCs/STs. This will ensure that the guilty persons are not only suitably punished but they also face departmental action."

Nikam, Government of Maharashtra, Higher and Technical Education Division, Mantralaya Annex Bhavan, Mumbai-400 032, is also enclosed herewith with a request to submit the information about cases of false SC/ST certificate holder and or any official inquiry conducted against them to the Dy.Registrar, B.C.Cell, Room No.143, University of Mumbai, Fort Campus, Mumbai-400 032 within a period of 30 days from the date of receipt of this circular to enable us to forward the same to the Government of Maharashtra and the University Grants Commission, New Delhi for necessary action.
