**Subject: - Implementation of Reservation Policy of the Government/UGC
for SC/ST in Universities and Colleges-Regarding.**

Sir/Madam,

You may kindly like to recall that the Hon'ble Prime Minister of India had announced that all the reserved backlog vacancies for SC/ST in Central funded institutions were to be filled by 31st December, 2005. While reviewing and progress of implementation, the Ministry of Human Resource Development and UGC observed that the institutions of Higher Education are not fulfilling the Constitutional commitments.

In pursuance of the decision taken in the Commission's meeting held on 6th November, 2008, I am directed to request you to take the following immediate actions: -

1. The University is required to adopt Reservation Policy for SC/ST circulated by the UGC in 2006 immediately, if not done earlier. It is to mention that no further Non-Plan grant will be released to University till such time this Policy is adopted by the University.
2. The University, which are deficient in the prescribed percentage of reservation, are required to fill up the backlog of reservation in teaching and non-teaching posts within 6 months. The advertisement for the backlog vacancies may be issued immediately and a compliance report alongwith the copy of the advertisement may be sent to the Commission within one month. **A portion of grant will be withheld until a status for full implementation of Reservation Policy is received from the respective Universities.**
3. The above decision may also be circulated to the Constituent and affiliated colleges of the University for immediate follow up action.

The undersigned is also directed to request you to take similar steps for implementation of reservation policy for OBC and Physically Challenged persons.
