The Principals of affiliated Colleges in Architecture are hereby informed that the recommendation made by the Faculty of Technology at its meeting held on 15th January, 2013 has been accepted by the Academic Council at its meeting held on 19th September, 2013 vide item No. 4.22 and subsequently approved by the Management Council as its meeting held on 18th February 2015, vide item No.07 and that in accordance therewith, in exercise of the powers conferred upon the Management Council under Section 55 (1) of the Maharashtra Universities Act, 1994, the Regulation 2230 is amended and Separate Regulation 8797 relating to Master of Architecture (By Research) as per Credit Based Semester and Grading System is introduced, which is available on the University's web site (www.mu.ac.in) and that the same has been brought into force with effect from the academic year 2013-2014 which is read as under:-

Regulation R 2230 for M. Arch. By Research

R.2230:- The thesis is to be submitted at the end of the second year. At least two months before submitting the thesis, a candidate shall forward to the Registrar through his guide and the Principal of the college a statement giving the title and a synopsis of the thesis along with the required fee. The candidate shall forward his thesis to the Registrar, through the Principal of the college of Architecture through which he has registered.

R.8797 :- M. Arch. (By Research , partly by papers) program under semester based Credit Grading system

The thesis is to be submitted at the end of the Semester IV, and at least one and half years after the date of registration.


At least two months before submitting the thesis, a candidate shall forward to the Registrar through his guide and the Principal of the college a statement giving the title and a synopsis of the thesis along with the required fee. The candidate shall forward his thesis to the Registrar, through the Principal of the college of Architecture through which he has registered.
