

## SIR MANGALDAS NATHUBHAI TRAVEL GRANTS FOR TEACHERS & RESEARCH SCHOLARS FOR THE YEAR 2013.

Applications are hereby invited from eligible candidates for the Sir MangaldasNathubhai Travel Grants for Teachers & Research Scholars to be awarded for the year 2013.

The Sir MangaldasNathubhai Travel Grants for Teachers & Research Scholars are to be awarded to teachers and research scholars of this University, preferably Hindus, for going abroad to attend seminars, to participate in symposia or to attend short courses, or for updating their knowledge or for catching up with the latest techniques and progress in any of the following subjects :-

- (a) Computer Science,
- (b) Environmental Science,
- (c) Pollution Control,
- (d) Biotechnology,
- (e) Genetic Engineering,
- (f) Life Sciences,
- (g) Industrial Engineering,
- (h) Mathematics and
- (i) Such other Modern Scientific, Technological, Industrial & Engineering subjects as may be approved by the Management Council of this University. Excluding the M.B.A. Course.

The teachers who are confirmed in permanent full-time service and who have put in at-least five years of continuous service in the University are eligible to apply for the travel grants, as per Regulation 2 of the regulations relating to the travel grants. However, the regulation do not provide for the eligibility criterion for research scholars. The travel grants will be a contribution towards travel expenses and may cover a single journey or return journey as the case may be. The travel grants will be available in any foreign country noted for advanced research in the above subjects.

The maximum amount of a single travel grants will be Rs.12,500/- or actual travel expenditure, whichever is less. Two travel grants will be awarded every year aggregating to maximum amount of Rs.25,000/- per annum or actual travel expenditure, whichever is less.

No grantee that has been awarded the travel once will be eligible for any further award of the travel grant for a period of three years after return to India. The grantees shall bear the excess amount of expenditure on travel, air-port tax etc., from their own resources or from any other source.

The candidates selected for the award of travel grants should travel in Economy Class by Air-India on sectors where it operates, and on sectors where it does not operate, air passage should, as far as possible, be booked through Air India. The candidates should, as far as possible avail of excursion tickets for air travel. The travel grants include the international travel, maintenance allowance, boarding, lodging, incidental expenses and internal travel within the foreign country concerned.

The grantees shall submit to the University through the Head of their Institution a report of the seminar, symposia or courses attended by them in the foreign country and a statement of accounts duly supported by vouchers in original, whenever possible, till the grant is fully utilized. The applications for the travel grants shall be forwarded to the University through the Head of the Institutions along-with an attested copy of each of the following documents:-

- (a) A full paper prepared by the applicant for presentation at an international seminar/symposia/conference;
- (b) Name of the foreign country, place and duration of the international seminar etc., in which the paper mentioned at (a) above is proposed to be presented;
- (c) A letter from the organizers of the seminar accepting the paper for presentation or a letter from the organizers of the seminar inviting the applicant to attend the seminar etc.

Applications for the travel grants should be made in the prescribed form and should be submitted to the Assistant Registrar, Scholarships Section, University of Mumbai, Room No.35, First Floor, M. J. Applications are hereby invited from eligible candidates for the Sir MangaldasNathubhai Travel Grants for Students to be awarded for the year 2013.

The Sir MangaldasNathubhai Travel Grants for Students are to be awarded to graduates of this University, preferably Hindus, for going abroad for doing either Doctoral or Post-Doctoral Research Work in any of the following subjects :-

- (a) Computer Science,
- (b) Environmental Science,
- (c) Pollution Control,
- (d) Biotechnology,
- (e) Genetic Engineering,
- (f) Life Sciences,
- (g) Industrial Engineering,
- (h) Mathematics and
- (i) Such other Modern Scientific, Technological, Industrial & Engineering subjects as may be approved by the Management Council of this University. Excluding the M.B.A. Course.

The travel grants will be a contribution towards travel expenses and may cover a single journey or return journey as the case may be. The travel grants will be available in any foreign country noted for advanced research in above subjects.

Candidates are required to forward with their application, certificates of their physical capacity to undergo the course of training and study which they propose to follow in the foreign country signed by a Registered Medical Practitioner of position and standing.

The maximum amount of a single travel grants will be Rs.12, 500/- or actual travel expenditure, whichever is less. The travel grants will be two, if the students are to be awarded for single air-fare and they will be one, if the return journey is also be covered, i.e. maximum amount of Rs.25,000/- per annum per student or actual travel expenditure, whichever is less.

No grantee who has been awarded the travel grant once will be eligible for any further award of the travel grant for a period of three years after return to India. The grantees shall bear the excess amount of expenditure on travel, air-port tax etc., from their own resources or from any other source.

## SIR CURRIMBHOY EBRAHIM & BAI KHANOUBAI NOORMAHOMED JAIRAZBHOY PEERBHOY SCHOLARSHIP FOR THE YEAR 2013.

### Two Free Scholarships for Muslims for Higher Studies Abroad.

Applications are hereby invited from eligible Mahomedan candidates for two scholarships for higher studies in foreign countries for Medicine, Philology, Ancient History, Economy, Arabic, Architecture, Town planning and Technological & Industrial subjects to be awarded out of the above Endowment Fund during the academic year 2013.

The scholarships are of the value of Rs.8,000/- each, p.a. tenable for a period of three years in Europe, America, Japan or other foreign countries for the purpose mentioned above and are open for competition to Mahomedan graduates of the University of Mumbai of not more than seven years standing from the date of graduation, who satisfy the requirements of the regulations relating to the scholarship. In special cases a one-year's extension of the period of tenure may be granted at the discretion of the Management Council. By the term date of graduation is to be meant the date of candidate's first passing an examination entitling him/her to receive a degree.

The stipends of scholarships will be payable in advance half-yearly installment to each scholar with effect from 1st July, 2013 onwards, or from the date of his/her leaving India, whichever is later, subject to the scholar's conduct and progress in the studies is satisfactory.

The following certificates in original should accompany every application :-

- (A) A certificate by a Registered Medical Practitioner bearing a date not earlier than 15<sup>th</sup> May, 2013, in the following form, testifying to the applicant's physical capacity to undergo the course of life and study which he/she propose to pursue in the foreign country, signed by a Registered Medical Practitioner of position and standing in the following manner :-

## EDULJEE DINSHAW SCHOLARSHIPS FOR THE YEAR 2013.

Applications are hereby invited from eligible Parsi candidates for the following scholarships to be awarded out of the EduljeeDinshaw Scholarships Endowment Fund during the academic year 2013.

- (A) Two Scholarships of Rs.500/- each per month for Secondary Technical Education.

Applicants must be Parsi students who have passed the Matriculation Examination in an Indian University or any University in Pakistan or the Secondary School Certificate examination held by the S.S.C. examination Board of Maharashtra State or any other examination recognized as equivalent to the Matriculation Examination of this University and have been admitted to the VeermataJijabai Technological Institute, Mumbai, Poona or Karachi College of Engineering Workshop Classes, or the Poona Agricultural College of the King George V. Institute of Agriculture, Sakrand, Diploma Course of the Architecture Section of the School of Art or any other similar Institution recognized by the Management Council. Candidates are not over the age of 19 if they are Matriculates and over the age of 22 if they are Graduates in Science.

- (B) One Scholarship of Rs.900/- per month for Higher Technical Education.

Applicants must be Parsi students who have passed the First year Examination in Science or the Intermediate Examination in Science or an examination recognized as equivalent thereto, of any Indian University or any University in Pakistan, and have been admitted to any degree course in the University Department of Chemical Technology or the VeermataJijabai Technical Institute, Mumbai, or College of Engineering at Poona or Karachi or the Agricultural College at Poona or the King George V. Institute of Agriculture, Sakrand, or any of the Indian Institutes of Technology, or any other similar Institution recognized by the Management Council.

- (C) One Scholarship of Rs.1,200/- per month for Post-graduate Technical Work.

Applicants must be Parsi candidates who have passed the B.Sc., B.Ag., B.Sc.(Agri.), B.Sc.(Vet.), B.Text., B.E. or B.Arch. Examination of any Indian University or any University in Pakistan with at least Second Class Honours, and who are graduate of not more than ten years standing from the date of their first passing a Degree Examination.

- (D) One Scholarship of Rs.1,500/- per month for study of a Branch of Technical Education in Foreign Country.

Applicants must be Parsi candidates who have passed the M.Sc., M.Ag., M.Sc.(Agri.), M.Sc.(Tech.) or M.E. Examinations of any Indian University or any University in Pakistan or such other University or Institution as may be approved by the Management Council and who are graduate of not more than ten years standing from the date of their first passing a Degree Examination.

The competition for the scholarship is open only to members of the Parsi Community professing the Zoroastrian Faith. The scholarships will be awarded in the first instance to Parsi's permanently residing in Karachi, failing such Parsi to Parsi permanently residing in Poona, and failing Parsi's of either of these two cities, to Parsi's of any other part of India or Pakistan.

Each of the above scholarships will ordinarily be tenable for a period of three years. The Management Council has the discretion to extend any of the scholarships to fourth year on grounds deemed sufficient by them.
