Mumbai School of Economics & Public Policy (Autonomous) conducts a **Full Time M. A. (Economics)** programme, Candidates whose names have appeared in **Third Merit list** are required to complete the admission process as follows :-

Submission & Verification of the following documents in person in the office of the Mumbai School of Economics & Public Policy (Autonomous), 3rd floor, Ranade Bhavan, University of Mumbai, Vidyanagari, Santacruz (E), Mumbai – 400 098 from 14th July, 2025 to 17th July 2025. Admission Fees can be paid in an online mode (on the activation of the link) only after verification and submission of the following documents.

1. Samarth Portal Form (online)(03 Copies) & Admission Form (Offline) (1 copy) & All Marksheets of Semester of F. Y., S. Y. & T. Y. / Grade Cards of B. A. (**03 self attested photocopies**) **along with the original Marksheet, evidence of Date of birth , Aadhar card for physical verification.**
10th, 12th Passing Certificate and TY marksheets (03 copies) (For other than Mumbai University Student) evidence of Date of Birth (03 self attested photocopy)
2. Cast Certificate, Income Certificate, Domicile Certificate (for all reserved category students of Maharashtra State) (03 self attested photocopies)(Non Creamy Layer certificate for NT, OBC ,SBC)
3. Non-Creamy Layer Certificate & Income Certificate valid for year 2025-26 (for VJ/DT-A, NT-B, NT-C, NT-D, OBC SBC, category students (03 self attested photocopies)
4. Gap Certificate Affidavit - if a student had a gap in studies after Graduation course (Original and 01 self attested photocopy)
5. Aadhar Card (03 self attested photocopies)
6. Undertaking Format A & B for all students, Format C for Reserved Category students and Format D for other than Mumbai University students , PG Registration Form (01 Copy)
7. Transfer Certificate form for Mumbai University Students . (attached in email)

Provisional admission will be given to candidates other than Mumbai University until eligibility criterion is fulfilled. Hostel seats are very limited, hence hostel admission is not guaranteed when admission to the department is done.

Reserved Categories candidates should be domicile of Maharashtra State and should belong to the categories notified by the Maharashtra State viz (a) Scheduled castes (including SC category persons who have adopted Baudha Religion) (b) Scheduled Tribes (c) VJ/NT, Special Backward Class and (e) Other Backward Class etc. Valid non-creamy layer certificate must be attached for OBC those categories which are required to submit it to claim reservation quota as per Govt. rules.
