Mumbai School of Economics and Public Policy, University of Mumbai, invites online applications for admission to Ph.D. programme in the subject of Economics under the faculty of Humanities for the academic year 2024-25 (Winter) from eligible candidates (with PET/NET/SET/GATE in Economics or Statistics). Desirous candidates can apply for the same at the online Ph.D. portal of the University of Mumbai (available at <https://uomphd.mu.ac.in>). **Every applicant will have to first register on the Ph.D. portal via the student login, following the Register Now button.** Subsequently, payment of application fees, filling the application form and uploading the relevant documents can be done, by logging in via the student login (**applicants must select Mumbai School of economics and Public Policy (MSEPP) as the department**).

Date of commencement of online applications: **6th January, 2025.**

Last date of online applications: **15th January, 2025.**

Following documents are required to be uploaded 'Online' along with duly filled Application Form.

1. Mark sheets of Graduate and Post-Graduate Degrees (Statements of Marks) and Degree Certificates.
2. PET (with one year validity)/ SET/ NET/ JRF/ GATE (in Economics or Statistics) Certificate or M. Phil. Passing and Degree Certificate.
3. Caste Certificate, Caste Validity, Non-creamy layer Certificate and all the relevant documents if any.
4. Person with Disabilities, kindly submit certificate issued by registered Government approved body.
5. Two-page writeup indicating your research interests (Research Proposal)
6. Hard copies of all the above mentioned certificates (Sr. No. 1 to 5 above) and the print out of the application form should be submitted by hand/post at the MSEPP office, 3rd floor Ranade Bhavan, Mumbai university, Vidyanagari, Kalina latest by the 17th January, 2025 during office hours (i.e. 10.30 am to 5.00 pm).
7. Reservation policy will be applied as per University of Mumbai Circular No. Enrol./Elg./Admission/2024-25/333/of 2024 dated 28th May, 2024.

Kindly refer to the University of Mumbai re-promulgated VCD No. Exam/Thesis/Univ/VCD/947 of 2018 dated 15th June 2021, for detailed rules, regulations, and eligibility conditions (available at the University of Mumbai website). The date of interview for short listing the candidates will be notified on the MSEPP website shortly after the application process is over. After the short listing interviews are over the admission of the shortlisted candidates will be finalized as per the guidelines given in the aforesaid VCD.
