**CIRCULAR :-**

The Management and the Principal of the college will be held responsible for the delay and further consequences, if any.

Also those colleges who do not have the teachers for CAS as per the 6<sup>th</sup> Pay Commission, should submit the report accordingly within 8 days from the issuance of this circular.

Those colleges who have already initiated the process of Career Advancement Scheme of their teachers as per the 6<sup>th</sup> Pay Commission, are requested to ignore this Circular.
