CIRCULAR :-

The Chairman / Secretary / Principals of all aided affiliated colleges in Arts, Humanities, Science, Social Sciences, Commerce, Education, Languages, Law, Journalism and Mass Communication, Music, Dance, Drama and Visual (Fine) Arts are hereby informed that the University has noticed that inspite of issuing the circulars some of the colleges have not yet initiated the Career Advancement Scheme to their teachers as per 6th Pay Commission. Therefore, once again they are hereby inform that the college should start the process on priority basis of Career Advancement Scheme of their teachers and should complete the process in all respect and submit the same on or before 30th April, 2014 to the University for further necessary action.

Also those colleges who have not yet initiated the Career Advancement Scheme process should submit an explanation for the same within 8 days from the issuance of this circular. If they fail to do so then the University will take strict action against the defaulter colleges.

Those colleges who have already initiated the process of Career Advancement Scheme are requested to ignore this circular.
