The students who have already filled the forms, but have *not* been allotted any seat in the First Round or those who have not been allotted a seat in the preferred branch in the First Round will be considered in the Second Round. The students who have not paid the fees after allotment of seat or those who have cancelled the allotted seat in the First Round will *not* be considered in the Second Round.

The applicant must be present in person at the time mentioned in the above schedule failing which his/her case will be considered as per the availability of the seats at the time of reporting.

Applicant who has been allotted a seat in the second round is required to follow the following procedure strictly to confirm the admission.

1. Submit the original Statement of Marks of T. Y. B. Sc. Examination.
2. In case of reserved category students, the original caste certificate should be brought for verification.
3. In case of OBC/SBC/NT/DT candidates, a non-creamy layer certificate for the current financial year (2013-14) should be submitted in original.
4. If the candidate fails to produce the required certificates in original at the time of admission, he/she will forfeit the claim for admission.
5. The candidate will be issued four copies of the challan for payment of the prescribed fees (For Open Category: ₹ 12445/- and for Reserved Category: ₹ 1295/-) in Allahabad Bank, Kalina Branch, Wadia High School compound, Ground Floor, Opposite Vidyanagari Campus. The candidate should pay the fees in the bank on or before Thursday, 18th July 2013. Two copies of the duly stamped Challan would be returned to the student by the bank.
6. One copy of the Challan should be preserved carefully by the candidate and the other copy (Department copy) should be returned to the Department office on or before 18th July 2013, failing which the candidate will forfeit the claim for admission.
7. All the candidates who are admitted in the second round are also required to pay refundable deposit of ₹ 800 in cash in the Department office. A separate receipt would be given to the candidate which should be preserved carefully.

The candidates admitted in the second round should note that the admission process is considered to be complete only when the candidate completes all the formalities mentioned in points 1 to 7.

If seats remain vacant after the second round, a spot round will be held on Saturday, 20th July 2013 at 11.30 a.m.

Regular classes of Semester I will begin from Monday, 22nd July 2013. The Time Table will be displayed on the Notice Board of the Department on 20th July 2013.
