(HI) degree programme is amended, which is available on the University's web site (www.mu.ac.in) and that the same has been brought into force with effect from the academic year 2013-14.

1. Provision for improvement of Internal Assessment (IA) marks in MEd. (HI) Sem-I &II Programme.

The Existing **Regulation 8616** relating to the Provision for reappearance be read as under.

The Existing **Regulation 8616** is as under:-

R 8616 Provision for Reappearance

For part –A: The candidate failing in course/courses (securing less than 50%) of part-A in semester-I/II/I& II will have to reappear for that course/s only.

For part –B:

- Viva voce will be conducted only when the candidate score 50 % or above in the content of dissertation. In case of failing in the content, he/she has to modify the content of the dissertation as per the suggestions of internal and external referees and resubmit to the university.
- If the candidate fails only in viva voce, he / she has to reappear only in the viva voce.

For part –C:

- The candidate failing in practicum/practical of part-C will have to reappear for that practicum or practical only.
- A candidate who fails in part-A, part-B and part-C fully or partially is allowed to reappear only for a maximum of 3 consecutive attempts
- If the candidate does not appear the semester end examinations fully or partially, he/she will be considered as a failure candidate. However, he/she is eligible for reappearing facility and his/her internal marks will be carry forwarded.

After some discussion, it was **resolved** that it be recommended to the Faculty of Arts that **Regulation 8616** relating to the Provision for reappearance be amended as under and that the same be brought into force with effect from the academic year 2012-2013

The amended **Regulation 8616** is as under:-

R 8616 Provision for Reappearance

For part –A: The candidate failing in course/courses (**Internal / semester end exam /both**) (securing less than 50%) of part-A in semester-I/II/I& II will have to reappear for that course/s only.

For part –B:

- Viva voce will be conducted only when the candidate score 50 % or above in the content of dissertation. In case of failing in the content, he/she has to modify the content of the dissertation as per the suggestions of internal and external referees and resubmit to the university.
- If the candidate fails only in viva voce, he / she has to reappear only in the viva voce.

For part –C:

- The candidate failing in practicum/practical (**Internal / semester end exam /both**) of part-C will have to reappear for that practicum or practical only.
- A candidate who fails in part-A, part-B and part-C fully or partially is allowed to reappear only for a maximum of 3 consecutive attempts
- If the candidate does not appear the semester end examinations fully or partially, he/she will be considered as a failure candidate. However, he/she is eligible for reappearing

facility and his/her internal marks will be carry forwarded.
